This is for the information of all concerned students that the admission for the **B. Com. (FYUGP) 3rd Semester** will be held on **10th August, 2026 (Monday)** and the admission for the **B.Com. (FYUGP) 5th Semester** will be held on **11th August, 2026 (Tuesday)**. All eligible students are hereby instructed to complete their admission within the stipulated dates.

Eligibility Criteria for the Fee Waiver Scheme

- **Income Limit:** The annual parental income from all sources must be **below ₹4.00 lakh**.
- **Exclusionary Condition:** Neither parent (father or mother) should be an employee of the State Government, Central Government, Semi-Government Organization, or any Government Undertaking.
- **Domicile:** **The student must be a permanent resident of Assam.**
- **Academic Performance and Attendance:**
 - The student's attendance in the previous academic year must **not be less than 75%**.
 - Students having **arrears/backlogs** or those who did not complete the form fill-up for the previous academic year's final semester examination are not eligible for the Fee Waiver Scheme.

Documents Required for Fee Waiver

- **Ration Card** issued by the competent authority of the Government of Assam (to be produced as proof of parental income).
- **Aadhaar Card.**

For B. Com (FYUGP) 3rd Semester Admission:

- Admission receipt of the 1st Semester.
- Marksheet of the 1st Semester Examination.
- Admit Card of the 2nd Semester Examination.

For B. Com (FYUGP) 5th Semester Admission:

- Admission receipt of the 3rd Semester.
- Mark sheets of the 1st, 2nd and 3rd Semester Examinations.
- Admit Card of the 4th Semester Examination.

Mode of Fee Payment

All students seeking paid admission must pay the prescribed admission fee online only through Google Pay, PhonePe, or any UPI payment mode at the College Payment Counter after verification of their documents on the same day. Students who fail to pay the admission fee on the date of counselling/document verification shall have their admission cancelled.

Students admitted under the Fee Waiver Scheme must collect their admission receipt from the College Payment Counter after completion of the admission process.
